- Add migration to online catalogs.
- AD & SSO are rolling out the first week of May. Initially SSO will be limited. Recommending Canvas, Starfish and Office 365 will be rolled out at the same time as SSO. This process is not a trivial migration. Roger requested grace from the colleges. A marketing campaign is in the works to inform students and colleges. Per Jill Stearns a student should be able to click submit and a screen should immediately pop up welcoming them and providing them with a student "W" number and information as to where to go next.
- Roger wishes to find 85K un funding to upgrade computers at Columbia College.
