Citizens' Bond Oversight Committee 4th Annual Report

MODESTO, CA – The Yosemite Community College District's (YCCD) Citizens' Bond Oversight Committee Chairperson James West, presented the fourth Annual Report to the YCCD Board of Trustees at their October Board meeting. The Annual report can viewed at http://www.yosemite.edu/bond/committee/.

The highlights of the 2008-09 Annual Report include:

<u>Modesto Junior College</u> - The completion of the Surface Parking Lot (455 stalls) on MJC East Campus, the ongoing construction of Ag Modular Living Units, the start of construction for the Allied Health Building, Ag Pavilion, Ag Animal Facilities, Softball Field at MJC West Campus, and donation of land for an MJC Educational Complex in Patterson.

<u>Columbia College</u> – The completion of the Public Safety Center (6,934 sq.ft. upgrade) and Madrone Building modernization, construction of the Child Development Center, groundbreaking of the Science and Natural Resources Building, and purchase of land for a Columbia College Educational Complex in Angels Camp.
