## Columbia College

#### MJC WEST SIDE EDUCATIONAL CENTER DECISION MAY BE COMING SOON

Two proposals being considered as a site for an MJC West Side Educational Center have made it to a second round of analysis. Both proposals are within the City of Patterson. One consisted of four options that range from a "build to suit" building, purchase of existing building, purchase of a building in design and land purchase. The other proposal includes donation of thirty acres of land and other off site improvements including an access street and joint use parking.

Kitchell Corporation provided an analysis of the two proposals to the Board of Trustees, at the Board's August 10, 2005 meeting. As a result of this presentation, staff was requested by the Board to present a second analysis of these site proposals to the Board's September 14, 2005 meeting based on a review of new submittals received. This analysis is based on a review of new submittals, which respond to YCCD desired educational building specifications and requirements within a budget constraint of \$5 million. Mr. Mark Newton of Kitchell Corporation and staff will present the report to the Board and receive direction as to which site to pursue.

#### CITIZENS' BOND OVERSIGHT COMMITTEE MEETING

The Measure E Citizens' Bond Oversight Committee's next meeting will be held October 5, 2005 from 6-7:00 p.m. at Columbia College in the community education classroom located in the Manzanita building.
