



# Measure E Bond Program Phase I Projects

#### **Program Description and Approach**

Phase I of the Measure E Bond Program for Modesto Jr. College includes a major capital improvement projects on both east and west campus. These include the Allied Health Building, the Agricultural Complex (Instructional Building, Greenhouse, Living Units, Pavilion and Animal Units), the Student Services Building, the new Parking Structure and the new Softball Field Complex.

Concurrent with the development of the designs for the first projects, the college has engaged BFGC to assist in determining the long term vision of both campuses to support growth in the most sustainable and environmentally sensitive way. This design effort will include:

Site Determination that will focus on the most appropriate locations for the new buildings and best possible locations for future sites. This will include the development of more campus quadrants that will encourage student, faculty and staff interaction and create indoor/ outdoor community spaces. This effort will include careful review of which campus program expansion will occupy and where new buildings will be sited.

**Sustainability Guidelines** that will establish construction techniques and goals consistent with Green Building Practices. This will include life-cycle costing, use of renewable resources, indoor air quality and passive and active solar systems.
