Paint interior masonry walls at Stairs 2, 3, 5 and 6, in lieu of clear seal noted in Finish Schedule, sheet A2.4

Provide power, A/V and data to instructors' lecterns for freestanding locations (power, A/V and data feeds through floor slabs to poke-throughs under lectern casework), fire sealed at second floor locations. Lectern casework is OFCI. Extend two (2) 1 1/4" conduits (one each for A/V and data) and one (1) 3/4" conduit (for electrical power) to poke-throughs at first floor locations. Quantity of cabling for power, A/V and data outlets to be provided for each freestanding lectern to match quantities shown in base contract documents for lecterns adjacent to room walls.
