15,776 MJC Passport to College Presentation

MJC President Dr. Richard Rose introduced Ms. Peggy Kroll, Director of Early College Programs at Modesto Junior College. Ms. Kroll explained that Modesto Junior College and Modesto City Schools are partnering to increase the area's college going rate by working with younger students to build an "I can do college" attitude and have created the Passport to College, an early-outreach project for 5th graders. The program was kicked off on January 17, 2008. MJC Foundation will raise funds to provide MJC full tuition scholarships to students who enroll at MJC following high school. Gigi Sheriffe was present representing the Foundation. The program has begun at three local elementary schools and has received 360 5th graders for the year. Incoming 5th grade students will continue to sign up for the next three years. Modesto City Schools (MCS) representative Melda Gaskins stated that MCS has committed to support these students and monitor their progress through high school. MJC instructor RoseLee Hurst worked with the Literature & Language Arts Department on a book drive which provided over 400 books to the 5th grade students. Donations were given to purchase "The Circuit: Stories from the Life of a Migrant Child" which each child will receive at the upcoming program celebration. Josefina Miller, Vice Principal at Orville Wright Elementary shared that this program represents an incredible opportunity for her students. Two Orville Wright students, Valentino Ortiz and Gladys Rivera, shared with the Board the reasons why they want to attend college. Trustees thanked the presenters and students for coming and are excited that MJC and Modesto City Schools have partnered in this program. Trustees expressed their gratitude to the MJC Foundation for providing tuition scholarships and invited the students to make MJC their home after high school.

15,777 Student Activity Reports

The Associated Students of Columbia College report was presented by ASCC member Reid Milburn. Ms. Milburn is also a representative for Region V to the California Student Senate. Ms. Milburn reported that ASCC sponsored its second successful mentor fair which provides mentors for local children. ASCC has partnered with Delta Blood Bank who is providing a \$300 student scholarship. ASCC recently hosted a voter registration table on campus. End of the year student activities are planned. ASCC continues to work in the student activity sticker program through partnering with local businesses who offer discounts to Columbia College students. The Sticker also offers discounts for sporting events at the college. ASCC members will be volunteering at X-Reg in August.

ASMJC President Taylor White reported that ASMJC has been in a rebuilding period for the last few months. Elections concluded in early April and ASMJC is doing well. In response to inquiry by Trustee DeMartini, approximately 170 votes were cast in the student election which represents about 1% of the student population. ASMJC is working with EOPS and CARE to sponsor an Easter party for MJC students' children. ASMJC members will be volunteering for SpringFling on April 12 and the Passport to College event on April 14.

15,778 Academic Senate Reports

Jim Sahlman, MJC Academic Senate President, reported that nine faculty received tenure at Tenure Ceremony held on March 25. There is high faculty participation regarding Accreditation, program review recommendation (#2). Mr. Sahlman anticipates that faculty will meet the May 31st deadline. The Academic Standards Committee is making excellent progress on syllabi recommendation (#3). In response to Accreditation recommendation #3, faculty hiring processes and procedures are being reviewed at MJC and Columbia College. A final draft is expected soon. Trustees commented that there have been great strides towards District wide consistency and much progress toward removing MJC from the Accreditation probation list.

Kathy Schultz, Columbia College Academic Senate President, reported that faculty working on the Basic Skills Initiative met with representatives of the Hewlett Recognition of Promise Program. The Curriculum Committee continues their work on implementation of Title V changes. Faculty is focused on program review and Student Learning Outcomes (SLOs) in preparation of the Midterm Accreditation report. Faculty will have summer technology training opportunities in online course development, CCC confer, WebCT, and others. In August, faculty will be available to assist students at X-Reg and attend a Summer Retreat. This is Ms. Schultz's last meeting as President. Anne Cavagnero will start her one-year term as Senate President next month.

Both Academic Senate Presidents will attend the April State Senate plenary session in Fresno.

Equine Open House

The MJC Agriculture Department and Equine Science Program are hosting an Equine Open House on Saturday, April 19, 10 a.m.–2 p.m. in the Equine Unit located next to the Mary Stuart Rogers Center Student Center on West Campus. The purpose is to create awareness of the new equine program while giving students a chance to show their work with horses. Students will provide demonstrations. Vendors will be on hand. Columbia College

President Joan Smith called the Board's attention to the following activities listed in the agenda:

Columbia Student
Outstanding Young
Californian

Alisha Cruz, age 20, is one of ten finalists for the Outstanding Young Californian award, which will be presented in Los Angeles. The Columbia College student was selected from a field of several hundred statewide entrants between the ages of 18 to 40. Criteria was based on achieving meaningful contributions to society or their local communities. Her mother, Suzanne Cruz, is a security officer at the college.

Survive and Thrive Conference

The Tuolumne County Chamber of Commerce, Calaveras County Chamber of Commerce, Mother Lode Job Training, Mother Lode Workforce Investment Board, and Columbia College are teaming up. About 120 participants, 20 presenters and 20 vendors will take part in the Mother Lode Business Services Summit 2008 "Survive and Thrive" on April 29 on the Columbia College campus. Activities will consist of workshops, keynote speakers, exhibits and networking.

Calaveras Center Art Show

Columbia College students' art will be featured at the college's Calaveras Center Art Show and Reception on April 4. The event is free and open to the public. Students are currently enrolled in Lori Hanson's art classes in beginning and intermediate watercolor and beginning drawing. Refreshments will be prepared by the college's culinary and pastry arts students. The art will be on display through April 26.

Symphony of the Sierra

The Symphony of the Sierra will provide a free community performance on April 12 at 5 p.m. in the Columbia College Dogwood Forum. Under the direction of Jeff Johnson, the orchestra consists of numerous talented local musicians and is conducted as part of a Columbia College music course.

Free Income Tax Preparation

Members of the Volunteer Income Tax Assistance (VITA) group are again offering free income tax preparation assistance for the public through April 15 in the Manzanita Rotunda.

Columbia Wine Tasting

The Columbia College Foundation is hosting the 32nd Columbia Wine Tasting on April 20 at Columbia State Historic Park. Proceeds benefit Columbia College Culinary Program, provide student scholarships and other program materials. More than 40 wineries will participate, along with local food purveyors, including the college's culinary students. Tickets are \$45.

Living with Lions Presentation

Over 70 people attended the Mountain Lion Foundation's Presentation on "Living with Lions" on March 14 at Columbia College. Presenter Emily Cunnison provided valuable information from studies on mountain lions. The presentation was highlighted with displays of a mounted mountain lion and an African lion, part of the Osterberg collection, which was donated to the Great Valley Museum. Guy Van Cleave, one of the museum curators and a Columbia biology professor, was instrumental in obtaining the lions.

District, Central Services

Chancellor Roe Darnell called the Board's attention to the following activities listed in the agenda:

Leadership Turlock

External Affairs Director Nick Stavrianoudakis reported that 25 leaders from Turlock will participate in "Leadership Turlock" on April 16, 2008, Board Chair Rojas, Chancellor Darnell and President Rose will address the group as they tour MJC's East and West Campuses. This event is provided as an opportunity for local leaders to become more familiar with MJC programs and services.

15,780 Presentations/Updates Accreditation Update

MJC President Rich Rose and Academic Senate President Jim Sahlman provided the Board with an update on MJC's Accreditation mid-term and special reports.

The College Strategic Plan is nearing completion. This is a big accomplishment as it is two months ahead of schedule. A program review survey, template documents and review processes have been developed. Substantial progress has been made and steady progress continues in preparing the Mid-term and Special Report due to the Accreditation Commission.

Enrollment Update

Columbia College Vice President Dennis Gervin reported that, at week 14 Columbia College remains ahead of Spring 2007 by 3.6%. It is anticipated that at the end of the Spring Semester, Columbia College will be ahead of Spring 2007 by 4.3%. Columbia College estimates a 4% growth for 2007-2008 over the previous year.

Dean of Instruction George Railey reported that MJC is currently ahead of Spring 2007 by 4.06%. Spring 2008 continues to show a strong growth trend. MJC does not anticipate the need to rollback FTES this year and expects to meet its 2% growth projection for Spring 2008.

Chancellor's Update

Chancellor Darnell reported that he received a legislative alert on AB 2277 supported by the Community College League of California (CCLC) regarding the property tax backfill issue. The Chancellor sent a letter of support and encouraged faculty to also respond.

Chancellor Darnell announced that the Board's Fall Retreat is scheduled for September 12, 2008 and asked trustees to confirm their calendars. The Board will conduct a study session on May 21, 2008, regarding our communities' educational issues. There will be no study session in April.

Chancellor Darnell also reported that the District-wide Budget Allocation Taskforce has completed their work and are preparing an executive summary of recommendations and findings which will be presented to the Chancellor's Cabinet and District Council for further action.

Fiscal Update

Ms. Scott reported the District received an AA3 bond rating from Moodys and an AA- rating from S & P, the highest ratings given to California Community Colleges. These ratings are the same as the District's prior ratings, even amidst the State's growing economic challenges. The District's sound fiscal management is the basis of the positive ratings. Bond insurance was purchased saving the taxpayers \$2.1 million. The District issued \$150 million in bonds last week. The funds are deposited with the County Treasury.

Ms. Scott further reported that the communication role between auditors and those charged with governance regarding the Statement on Auditing Standards 114 (SAS 114) now require that communication at the beginning of the audit process. The Board chair and other interested Board members will be invited to a pre-audit conference with District fiscal representatives and auditors.

Bond Update

Kitchell representative Mr. Mark Newton provided the Board with the following update on Measure E projects.

Citizens' Bond Oversight Committee – The YCCD Citizens' Bond Oversight Committee (CBOC) met on Wednesday, April 2, 2008, at Columbia College, following a tour of campus projects.

Columbia College: Child Development Center: The Division of the State Architect's back check process has begun, construction should start in July. Science and Natural Resources: The schematic design has been completed and the

project is being cost estimated. The project has recovered from a minor scheduling setback. *Public Safety Center:* The project has bid and construction is expected to start in May. It is three months ahead of the Program Management Plan schedule and has come in \$400,000 below budget. The *Madrone* project's DSA back check is near completion. The project is expected to bid in April, with construction to begin in June. The project has been delayed due to a prolonged plan check process.

Modesto Junior College: Campus Master Plan: The College has reviewed the most recent draft of the plan and supplied comments. A campus wide forum was held to present the plan. All requested changes have been made to the plan and a final draft will be provided to the Board to review. The Multi-Use Pavilion project has completed the design development phase. and a cost estimate is currently being developed. The design phase for the Beef Unit and Sheep Unit is near completion. Allied Health project's construction documents will be submitted to the state upon completion. Construction is expected to start in Fall of 2008. The Parking Garage project has been divided into two phases. The parking lot designers are preparing a fee proposal to begin the design work. The Auditorium project is 93% complete and construction should be complete in June. Softball Complex: The geotechnical work is complete and being analyzed. Science Community Center: The schematic design phase is completed. Current design activities include the design of the labs and lab prep spaces. MJC Student Services Project: A college forum was held yesterday and input was received from the college community. Hall: A college forum is scheduled for this Friday to discuss minimization of loss in FTES and disruption to staff and students. Parking Lot: Chancellor Darnell reported that the lot line is being adjusted, alternate locations are being identified for the media and community education departments, lease negotiations are on track, and construction is projected to begin in July and complete during the Ffall term.

Calaveras Educational Site: The College and District have begun negotiations. Oakdale Educational Site: The College and District are reviewing possible sites. West Side Educational Site: The College and District are considering various site offers. Turlock Educational Site: Various properties are being considered for a future location.

15,783 CCCT Board of Directors Elections 2008

Chancellor Darnell reported that the voting period for the California Community College Trustees Board of Directors takes place between March 10 and April 25. There are 20 candidates for ten two-year vacancies on the Board. The candidates are listed on the attached sheet. Biographical sketches were distributed previously to Trustees.

A motion was made by Trustee Neumann and seconded by Trustee Dean that the Board of Trustees each complete a ballot indicating their preferences for the CCCT Board and forward to the Chancellor for compilation; and direct the Chancellor to complete and submit a single Board ballot.

The motion carried with a vote of 7-0.

15,784 Negotiations - CSEA

Chancellor Darnell and Assistant Chancellor Gina Rose reported that discussions with the California State Employees Association (CSEA) regarding 2007-2008 contract negotiations are continuing. A tentative agreement on salary has been reached. CSEA has approved the Tentative Agreement through their ratification process. Staff will receive retroactive payment for services rendered beginning July 1, 2007.

A motion was made by Trustee Neumann and seconded by Trustee Hallinan that the Board of Trustees approve the attached 2007-2008 negotiated agreement on salary, as amended, with the California State Employees Association (CSEA).

The motion carried with a vote of 7-0.

15,785 Board Subcommittee

Trustees identified the need for broader community awareness in addressing the need for higher college going rates and success rates of students in the Central Valley. Trustees discussed ways to actively promote the District's colleges and successful student programs in our communities. The Board's desire to be proactive led to further discussion regarding the appointment of a Board subcommittee to work with the Chancellor to develop an action plan. That plan should include an ongoing process to allow Trustees to support student success initiatives and assist with the promotion of

our colleges as a viable and affordable higher education option. Board Chair Rojas identified four possible trustees to serve on this three member subcommittee: Paul Neumann, Linda Flores. Desirree Abshire and Anne DeMartini.

A motion was made by Trustee Dean and seconded by Trustee Flores that the Board of Trustees approve the formation of a Board Subcommittee to address the need for higher college going rates and success rates of students in the Central Valley; and that no more than three trustees work with the Chancellor to develop an action plan.

The motion carried with a vote of 7-0.
